**Subject:** Ordinance Amending the Animal Control Code - Ord. 2009-12(c)  
**Date:** September 15, 2009

At the August 24, 2009 Assembly meeting Ord. 2009-12(b) An Ordinance Amending the Animal Control Code, was introduced and set for public hearing at the September 21, 2009 regular Assembly meeting. Since introduction changes have been made to the language of Ord. 2009-12(b) in response to public comment, resulting in a version (c). The changes include the following:

## **08.05.010 Definitions.**

Competent voice control means when all the following are met:

...

Version (b): (1) *The person exhibiting voice control has the dog under verbal control and within sight at all times regardless of distractions (such as wildlife, traffic, other animals, food, other people or noise);*

(2) *The dog under voice control does not bark at, jump on, act aggressively toward, or advance on people or other domestic animals; and*

Version (c): (1) *The person exhibiting voice control has the dog under verbal control; and within sight at all times with only brief lapses, regardless of distractions to the dog (such as wildlife, traffic, other animals, food, other people or noise);*

(2) *The dog under voice control does not jump up on a person without invitation, or aggressively bark at or advance on a person or domestic animal; and*

**08.20.010 Impoundment generally.**

...

Version (b): (d) After the expiration of the five-day impoundment period, impounded animals not claimed by their keeper may be disposed of by the Humane Society by adoption, sale or destruction by humane means.

Version (c): (d) After the expiration of the five-day impoundment period, impounded animals not claimed by their keeper may be disposed of by ~~the Humane Society by adoption, sale or destruction by humane means~~ *euthanasia*.
