

**2009 APPLICATION FOR ENGRAVING NAME ON THE  
ALASKA COMMERCIAL FISHERMEN'S MEMORIAL IN JUNEAU**

**INSTRUCTIONS:**

The information requested in this Application Form is to insure that the names engraved in the Memorial were commercial fishermen or women, that they are deceased, and that the spelling is accurate. This Application is an invitation to you to add a name to the Memorial and does not bind or obligate the Memorial to any performance on its part. The price for engraving is subject to change without notice at the sole discretion of the Board of Directors of the Memorial. Also, the Memorial must have a sufficient number of names submitted each year in order to make it cost effective for the engraver to fly to Juneau, and engrave the names. Generally, it is not known until late April if engraving each year is financially feasible.

Engravings on the Memorial are limited to the person's name, vessel name, date of birth, and date of death. If the person was lost at sea (in other words, the body has never been found), they may have a "star" added to the end of their name. Each name engraved on the Memorial may have a maximum of two lines per name, and each line may have only 26 characters, including spaces, per line.

The following examples are provided to illustrate the names, vessels, and information that could be engraved because the information and number of characters per line meet the criteria set forth above:

Jonathan Swift\*  
or:  
Jonathan Swift, F/V Majors  
or:  
Jonathan Swift, F/V Majors\*  
May 3, 1883-June 18, 1911

You may send in any articles or pictures of this person and we will maintain the information in a notebook established for this purpose. Attach more sheets if you like.

You also agree that the Memorial, its officers, directors, and members are in no way responsible or liable to any one for any errors or omissions in engraving any name or accompanying information or for the fact that the name is engraved and you agree to hold such officers, members, and directors of the Memorial harmless from any liability for any errors or omissions in engraving said name.
