Mr. White says that we can fund the full \$318.00 amount to Kaia Hamrick and fund the rest to Juneau Jumpers.

Mr. Rutecki says he would like to fund all of them equally if they can.

Mrs. Lange says that the total will be 19 participating and if divided evenly each participant will be able to get \$127.34. If we were to fully fund the swimmer and allocate the rest to Juneau Jumpers it would work out to be around \$116.00 per person.

Mr. White says his question is are the Juneau Jumper kids going to go regardless and how many kids are going.

Mr. Pusich confirms that 18 kids are going to go with the help of Lisa Worden from Juneau Jumpers. They made their reservations and they are good to go for their trip already.

Mrs. Lange says that she is in favor of fully funding Kaia Hamrick and allocating the rest to the 18 kids.

Mr. Rutecki says that he is more in favor of awarding all participants the same amount.

Mr. White asks when the Juneau Jumpers are leaving and when the swimmer leave.

Mr. Pajinag confirms that the Juneau Jumpers start their trip on June 26, 2015.

Mr. Pusich says that the swimmer meet has already taken place and that the parent got the form in a little late and missed our last meeting date but it was turned in before the event took place.

Mr. Rutecki says that Kaia Hamrick did travel with a big group of swimmers.

Mr. White says since the meet is already over that we should probably do it all equally.

Mrs. Vick makes motion to divide what is left of the budget among the 19 participants.

Mrs. Lange confirms that it will be \$127.34 for Kaia Hamrick and \$2,292.16 for Juneau Jumpers.
