**ORDINANCE OF THE CITY AND BOROUGH OF JUNEAU, ALASKA**  
**Serial No. 2012-37**

**An Ordinance Amending the Traffic Code Relating to Parking.**

BE IT ENACTED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

**Section 1. Classification.** This ordinance is of a general and permanent nature and shall become a part of the City and Borough Code.

**Section 2. Amendment of Section.** CBJ 72.14.020 - Parking payment, is amended to read:

**72.14.020 - Parking payment.**

(a) The parking ~~payment~~ *management* plan shall specify the number and arrangement of the parking spaces in each parking payment area. Spaces and areas shall be designated by pavement markings and/or signs as appropriate.

(b) No person shall park a vehicle in a parking payment area without registering, and paying if required, for the use of all spaces occupied or partially occupied by their vehicle.

~~(c) No person shall park a vehicle other than a motor vehicle in a parking payment area without depositing a payment for the use of all spaces occupied or partially occupied.~~

1           **Section 3. Amendment of Section.** CBJ 72.28.010 - Definitions of words and  
2 phrases, is amended to read:

3           **72.28.010 - Definitions of words and phrases.**

4           The following words and phrases, when used in this title, shall have the meaning  
5 respectively ascribed to them in this section, unless the context clearly indicates  
6 otherwise. Words or phrases used but not defined in this title which are defined in state  
7 laws or regulations pertaining to the operation of vehicles shall have the meaning  
8 ascribed to them by such state law or regulation, unless the context clearly indicates  
9 otherwise.

10           ...

11           *Registration means to complete a process in order to obtain a parking privilege.*  
12           *Registration shall be valid for the limited time indicated on the receipt, hang tag, or*  
13           *permit obtained. To be valid, any registration or payment must be completed correctly*  
14           *as indicated on signage, receipt, hang tag, or permit, including inputting the correct*  
15           *license plate number, parking space number, or other data as indicated.*

16           (i) *When parking payment or registration is by display of a receipt, hang tag, or*  
17           *permit, to be valid, the receipt, hang tag, or permit, must be displayed in the*  
18           *vehicle as indicated. Only the most clearly and prominently displayed receipt,*  
19           *hang tag, or permit shall be valid.*

20  
21           Residence district means the territory contiguous to and including a highway except a  
22 controlled-access highway and not comprising a business district, if the property  
23 fronting the highway for a continuous distance of 300 feet or more is in the main  
24 improved with residences, or residences and buildings in use for business.
